




About Us

Say Earth is a non-profit Delhi NCR based NGO, founded in the year 2020 by Lake & Water Conservationist **Mr. Ramveer Tanwar** and Environmentalist **Mr. Mohit Relan**. Our primary focus is environment conservation, transformation and rejuvenation of water bodies and urban forest making across India.

An initiative that started with *Jal Chaupals* (a platform for discussion on water conservation and waterbodies rejuvenation in local communities), transformed into environment conservation, urban forestry and saving our natural resources like lakes, ponds, wetlands to restore the ecological environment surrounding the waterbodies.



Objective: To conserve environment, restore depleting water table to maintain the hydrological cycle and revive our eco-system by rejuvenating Ponds and creating Urban Forests.



Vision: To create a better environment for future.



Mission: To be a knowledge & execution partner of NGOs, Corporates and Government entities to address global environmental issues.

To address environmental issues and depleting water table, Say Earth is working extensively in multiple aspects of environment conservation, as under:

How We do?



Jal Chaupal & Awareness - A platform for discussion on water conservation and waterbodies rejuvenation.



Clean-Up – Removal of non-biodegradable and inorganic waste; organic & inorganic waste is segregated, processed as manure, and recycled as appropriate.



Rejuvenation – Cleaning, Earth excavation, De-Silting from Pond/lake; Dam/Ramp for Bundh formation.



Filtration & Water Quality Management – Multilayer Pits, Constructed Wetland, Eco/Bio-Remediation etc.



Afforestation – Plantation, Seedball Making & Nursery creation



Rain Water Harvesting - Creating small check dams, Kunds/well, ponds, to tap rain water.



Environment Awareness - Nature Walk, Wall Painting & Waste-To-Art workshops



Landscaping – Fencing, Mini-Nurseries










